**THE PREZ SEZ**

Just about the most significant thing to happen to the Amateur Radio service in 30 years is about to begin. It was about 30 years ago that incentive licensing was rolled out, just in time to take away my general class privileges for which I had worked so hard. I still had a general class ticket on the day incentive licensing took effect (1 October 1968, as I recall), but far fewer frequencies on which to operate.

With any luck, that won't happen this time. FCC is in the biennial review process and if we (hams) did nothing, FCC would, on their own, come up with a simplified structure and changes to the rules we have now. There would be a review process, but in the end, things would change.

In order to make this work to our favor, the ARRL Board of Directors has (over the past 30 months or so) been working on a long range proposed restructuring. Adopted by the Board of Directors on July 18, 1998, the proposed new structure would not reduce anyone's operating privilege, and would in most cases give everyone some new band or sub-band operating space. The only ones not getting new space would be our present no-code tech licensees. This is much better than the fiasco 30 years back that instantly reduces the privileges of most of the amateur radio population.

Lots of changes have occurred in the last 30 years, most of them crafted to increase our access to this

wonderful hobby. I believe the ARRL proposal goes a long way to secure operating privileges and encourage hams and non-hams alike to stick with the hobby. I think it reflects the reality of operating practices today, and gives us hope for the future. In short, I agree with and support the proposal the way it is written. I have read it, kept up with the discussion of the issues over the last few years, and will continue to do so as this proposal goes through the comment process once a petition for rule making has been submitted.

I hope you will eventually comment if you have something to say, and that you have something to say after reading the background information and the entire proposal. I also hope you keep the best interests of Amateur Radio service in mind when you evaluate this proposal. At this point the one to contact is Brad Wyatt, K6WR, our Pacific Division ARRL Director. he can be reached via e-mail at bwyat@arasmith.com, or k6wr@arrl.org. If you don't have access to e-mail, write to him at his call book address. September QST will have a full discussion of the proposal. If you are not presently a member of the ARRL, now is a good time to come on board and make your feelings known.
